



## **MTC GUEST POLICY & FEES**

### **Guest Policy Summary:**

This is a summary of the Marin Tennis Club current guest policy. This policy is subject to change by the Board of Directors at any time, without prior notice. MTC allows its members to bring an **unlimited number** of different guests during the year, and to bring guests **on any day and at any time** during the week and weekend.

### **Guest sign-in:**

All guests must be registered by their hosting member with one of our Guest Services staff members upon arrival. Every guest 18 and older must complete a waiver acknowledging their "Assumption of Risk, Waiver and Release" the first time they visit the Marin Tennis Club. The host must be a member in good standing. Guest registration is required for both 'free' guests and guests to be charged. Members must accompany their guests and may not leave them unattended at the club.

### **Guest Policy:**

- Guests living within 100 miles of the club are limited to 2 tennis visits a month with a maximum of 24 visits per year. Guests residing 100 miles or further may be considered houseguests. (See more details below)
- Members must check in guests and both the member and guests are responsible for making sure that the maximum number of monthly and annual visits are not exceeded.
- If a member does not check in a guest a fee of an additional \$10 will be billed to their account. Guest fees remain \$10 so the total billed if you do not check in a guest is \$20.
- If a member brings a guest who has already been to the club twice that month, they will incur an additional charge. An additional \$25 will be billed to the host member's account if a guest is playing a 3<sup>rd</sup> time in a month and \$50 for a 4<sup>th</sup> time in one month.

### **Limits on Members bringing guests:**

- Members may bring an unlimited number of different guests during the year.
- Members may have a maximum of 2 tennis guests on a court at any one time, a member may be allowed to exceed this limit with at least 24-hour advanced notice and with GM approval.
- A member planning to invite more than five swim guests on any one occasion requires pre- approval from the Club office.

### **Guest Fee Payment:**

Where fees are applicable, guests may pay with cash or check, or the member may select to host and be billed to their statement.

### **Guest Fees for Tennis:**

Guest fees are \$10.00 per guest, per day. Guests may use the other MTC facilities for the whole day - pool, spa, sauna, fitness room and dining. The host is required to accompany the guest

on and off the courts.

**Guest Fees for Swimming:**

Guest fees are \$10.00 per day. Guests may use the other MTC facilities for the whole day – tennis, spa, sauna, fitness room and dining. The host is required to accompany the guest both in the swimming area and around the club. Note swimming pool guest fee is waived for any child five years and under.

**Exceptions:**

- Play Tennis Marin is included as league play, and we waive the fee.
- Outside players on current USTA teams are allowed to play in team practices without paying the guest fees. Because our outside players pay \$50 a season to sign up for our teams (in addition to their \$30 USTA fee) and because we want them to be successful on our teams; they don't pay guest fees for organized team practices. Organized team practices require the captain and/or co-captain to get approval from the General Manager before play.

**Houseguests:**

This policy applies to guests whose permanent residence exceeds 100+ miles from MTC. They must be staying at the home of a member, or sponsored by a member they are visiting and/or be a former MTC member and staying in Marin. The cost is \$100/month max 2 months annually.
